REPORT OF THE SUPERVISORS OF THE INSANE FOR THE STATE OF VERMONT

Montpelier, Vermont, June 30, 1932

Dear Sir:

The Board of Supervisors of the Insane, in accordance with the requirements of Statute, submit the following report of their activities and services to the insane for the biennial perod ending June 30, 1932.

Once each month the Board has visited the State Hospital at Waterbury and the Brattleboro Retreat at Brattleboro; and at least once a year has visited the Lake View Sanatorium and the Green Mountain Sanatorium at Burlington.

These visits give the patients an opportunity to consult the Supervisors about any grievance, or for advice upon any matter whatever, and this opportunity is freely exercised so that the interests of the patient are safeguarded as well as the interests of the State in that no patient is retained if their discharge can be made without injustice to the patient or menace to the community or family where they would go.

In preparing the appended tables the part-pay patients are included with those supported wholly by the State. They are of some expense to the State in any event, but as a matter of fact many are wholly supported by the State, as the ones ordered by the Probate Court to pay, cannot, or at least do not, make the payments. It is probably true that if they cannot afford to pay more than two, three, or four dollars a week, they cannot afford to pay at all.

You will observe from the tables that there are at the State Hospital 44 more patients, both State and private, than there were two years ago. At the Brattleboro Retreat, not taking into account the private patients, there are 16 more State patients than two years ago; making an increase of 60 in the two hospitals during the biennium. This increase of 30 patients a year is somewhat larger than the average yearly increase during the past ten years.

This increase has occurred notwithstanding the efforts of the Board to discharge every case than can be safely cared for at home or which does not properly belong in a hospital for the insane.

You will observe from the tables that the Board has discharged 238 patients during the biennial term of which 215 were conditional discharges, and that 77, discharged during this or some previous biennial term, have been returned upon revocation of the conditional discharge by our Board; or about one revocation for every three discharges. This proportion is about the same as in former years.

It seems best to allow these patients to go home, even if they have to be returned in a few months or a few years. They have a right to be freed from detention and besides it keeps the hospital population at a minimum.

It seemed some years ago that the peak of our hospital population was near at hand, yet the increase still goes on as friends and relatives realize more the advisability of hospital treatment for persons who are actually insane, rather than home care with all its burden and trials. They realize such a course is better for the patient as well as better for the family.

The hospital conditions and facilities are very good at the Lake View Sanatorium and the Green Mountain Sanatorium. both at Burlington. These two institutions are licensed by the Board of Supervisors to receive and care for insane patients.

The Brattleboro Retreat, in its wards, buildings, and appointments, is in better condition as a hospital for the insane than it has ever been before. During the biennium there has been completed, and now occupied, the Ripley Nurses Home, a commodious and modern structure, four stories high, with accommodations for seventy-five female employees.

Two cottages have been completed and two more are in process of construction.

There is also under construction an infirmary with a capacity of ninety patients.

Altogether the Retreat is a model institution under the efficient management of its superintendent, Dr. Horace G. Ripley.

At the State Hospital, automatic sprinklers have been installed which not only safeguard the patients but more efficiently protect the property.

From the appropriation made by the last legislature there has been completed and now about to be occupied, a new building with accommodations for one hundred patients. This added rooming space comes just in time as the hospital capacity had become practically occupied.

This building is equipped with facilities for hydro-thermic and hydro-electric treatment which, with all the other well ordered wards and dormitories, make the State Hospital compare favorably with other institutions of its class wherever located.

Under the efficient management of the superintendent, Dr. E. A. Stanley, friends and relatives may be assured that the patients committed there will have the best of care and every consideration given to their comfort and improvement.
